Brisbane, Australia 12 July 2019: Factor Therapeutics Limited (ASX: FTT) has released its Appendix 4C for the June 2019 Quarter.

The Company held cash reserves at the end of the quarter of \$3.360 million. Operating cash outflows during the quarter totalled \$1.040 million, of which \$0.855 million related to payment of costs associated with the Phase 2b clinical trial of VF001 which completed in November 2018.

Following the Phase 2b trial result the Company has managed the orderly completion of previous research and development activities and implemented significant cost minimisation initiatives.

The Company's focus remains on maintaining its intellectual property portfolio, while the Board continues to assess potential new technology acquisitions for the Company's future direction.
