

BACKGROUND

- A TGH and CITIC entered into a Memorandum of Understanding dated 10 April 2007 recording the key terms of their in principle agreement in relation to their investments in Investigator Resources Limited (then known as Southern Uranium Limited) (IVR).
- B TGH and CITIC enter into this document to record the termination of that agreement and the Memorandum of Understanding.

AGREED TERMS

1. TERMINATION

TGH and CITIC terminate the in principle agreement and the Memorandum of Understanding referred to above, with effect from the date of this document.

2. ACKNOWLEDGEMENT

TGH and CITIC acknowledge that:

- (a) their respective investments in IVR remain separate and independent investments by each of them and are not held jointly and severally;
- (b) there is not, and has not been, any partnership between them with respect to their respective investments in IVR;
- (c) neither party is responsible for the other party's obligations under the income tax laws of Australia or any other applicable jurisdiction;

(d) neither party has any claim against the other party in relation to the formation, performance or termination of the in principle agreement or the Memorandum of Understanding.




