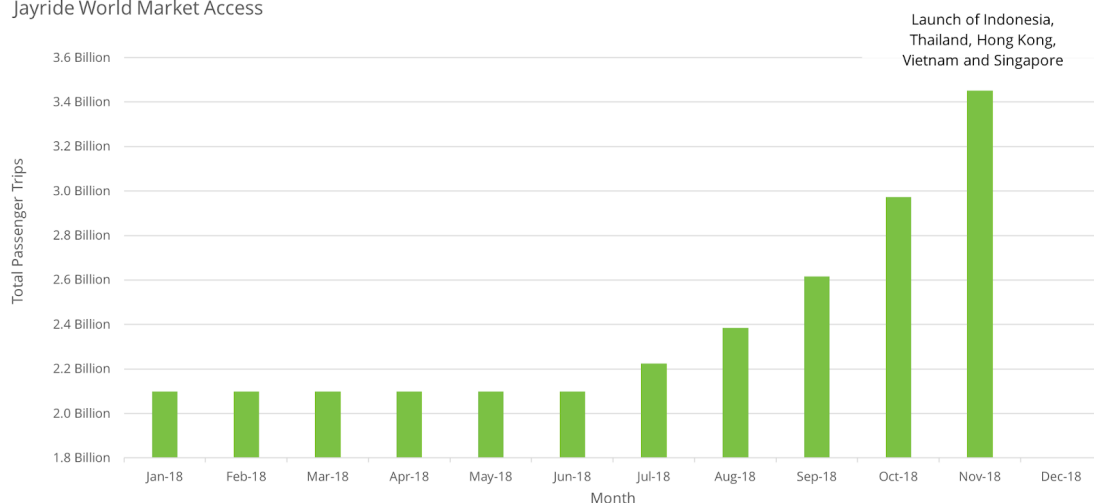

Jayride launches in Asia: Indonesia, Thailand, Vietnam, Singapore and Hong Kong

Jayride Group Limited (ASX:JAY) ("**Jayride**" or the "**Company**") the e-commerce marketplace that allows travellers to compare and book airport transfers from 3,000+ transport companies, is pleased to announce the launch of Jayride in five new Asian countries: Indonesia, Thailand, Hong Kong, Vietnam and Singapore.

Jayride has launched 5 additional countries, 33 additional airports, with 102 new transport companies, growing Jayride's market access by 482 million passenger trips, to a total of 3.5 billion (45%¹) of the world's total airport passenger trips.

Jayride World Market Access



Jayride is now available for travellers to book airport transfers in Indonesia (at 17 airports), Thailand (at 9 airports), Hong Kong (1 airport), Vietnam (at 5 airports), and Singapore (at 1 airport), which includes every airport with greater than 25,000 international passenger trips per year.

At these airports, travellers can now choose the best transfer for them from over 102 private transfer and shared shuttle companies.

For Jayride, today's launch of Indonesia, Thailand, Hong Kong, Vietnam and Singapore is the country's first set of Asian market launches, and is a continuation of Jayride's global expansion, as part of Jayride's international market capture strategy. These 33 airports service 482 million passenger trips each year, which is 6% of the world's 7.7 billion total annual airport passenger trips.

These launches increase Jayride's market access to 3.5 billion (45%) of the world's 7.7 billion total annual airport passenger trips.

Transport companies in these five new Asian countries now available to book on Jayride include great local private car and shared shuttle services, and even popular international transport brands.

They service popular destinations, including:

- Denpasar airport to Ubud,
- Phuket airport to Bangla Road,
- Hong Kong airport to Tsim Sha Tsui promenade,
- Ho Chi Minh City airport to Binh Tay Market, and
- Singapore Changi airport to Marina Bay Sands,

These transport services are now available to be booked by Jayride users.



Continuing international expansion

Jayride's international expansion initiative started in May with the release of Jayride's new transport technology platform. Launches of new countries are successful, accelerating, and expected to continue. Recent significant milestones are summarised below:
