Appointment of Simon Fitzgerald as General Manager Production and Engineering

Simon Fitzgerald joins Janus Electric as General Manager Production and Engineering, bringing deep operational and engineering expertise in electric commercial vehicles.

Mr. Fitzgerald has been at the forefront of electric bus deployment in Australia, with a strong track record in delivering commercially viable vehicle platforms at scale.
