COMPLETION OF PLACEMENT

As announced on 6 February 2017 Key Petroleum Ltd (Key or Company) has completed a \$1,000,000 placement (Placement).

Funds raised under the Placement will be expended by Key on the following:-

- Funding Key's share of work commitments in the Perth Basin;
- Assessment of new venture opportunities; and
- Additional working capital.

Key issued under the Placement 250 million shares on 7 February 2017 to a sophisticated investor (170 million shares) and an existing shareholder (80 million shares).
