Until after becoming the trustee, the Director was unaware that the trust property included 7,000,270 shares in the company. By virtue of becoming trustee, the Director became the legal owner of the shares as trustee but, at no time, had a beneficial interest in the shares, paid no consideration for the shares and is not a beneficiary of the Avebury Family Trust. There was no trade as, at all times, the shares were the property of that trust.
