Late Lodgment of Appendix 2A

Please find attached, an Appendix 2A *Application for Quotation of Securities* (**Appendix 2A**).

The reason for the attached Appendix 2A is that Kina Securities Limited (**ASX:KSL | PNGX:KSL**) (**Kina** or the **Company**) has just become aware that it has not advised the market of the issue on 27 November 2020, of 1,145,980 new fully paid ordinary shares to eligible Papua New Guinea retail shareholders, being the shortfall from the Placement and Entitlement Offer announced on Thursday, 10 September 2020 (**PNG Offer**), as advised by the Company in its ASX/PNGX Announcement "Completion of PNG Retail Offer" on 11 November 2020.

For the purposes of Listing Rule 18.7, Kina provides the following information:

1. The late lodgment of the Appendix 2A is due to an administrative oversight by the Company. As soon as the oversight was identified, the attached Appendix 2A was lodged with the ASX and PNGX.
2. Kina has a *Continuous Disclosure Policy* and a *Shareholder Communications Policy* which document the procedures adopted by the Company to ensure compliance with its continuous disclosure obligations under the ASX and PNGX Listing Rules.
3. Kina confirms that following this incident, the Company has reviewed its processes and believe that the Company's disclosure arrangements are adequate and are being enforced and that this was an isolated incident which does not involve any substantive breach of the ASX and PNGX Listing Rules.
