Issue of Placement Shares - Notice pursuant to Section 708A(5)(e) of the Corporations Act 2001

Los Cerros Limited (ASX: LCL) ("Los Cerros" or the "Company") is pleased to advise that it has issued and allotted a total of 750,000 fully paid ordinary shares ("**Placement**" shares) at \$0.04 per share, under part 2 of Tranche 2 of the Placement to sophisticated investors as announced on 13 July 2020 and approved by Shareholders at the General Meeting held on 27 August 2020. A total of 38,750,000 Tranche 2 Placement shares have been issued under Listing Rules 7.1 and 10.11.

The Corporations Act 2001 ("Act") restricts the on-sale of securities issued without disclosure, unless the sale is exempt under section 708 or 708A of the Act. By giving this notice, the shares issued pursuant to the Placement ("**Shares**") and noted in the attached Appendix 2A will fall within the exemption in section 708A(5) of the Act.

 - 1. The assets and liabilities, financial position and performance, profits and losses and prospects of the Company; or
