Announcement of Entitlement Issue

Traka Resources Limited announces a non-renounceable pro-rata issue of up to 111,848,198 fully paid ordinary shares at a price of 1.5 cents each to all shareholders of the Company as at 30 July 2015, on the basis of 1 share (New Share) for every 1 share held, to raise up to \$1,677,723 before expenses of this issue, which are estimated to be \$17,000.

The purpose of the issue is to fund exploration and evaluation expenditure arising from the Company's recent agreement to earn into the Yallalong Project, further exploration on the Company's existing projects, evaluation of new projects and to meet ongoing overhead expenditure.
