CLEANSING NOTICE AND APPENDIX 3B EXERCISE OF OPTIONS

- (2) 12,500,000 new Ordinary Shares in LKE at nil cash consideration upon the conversion of unlisted Performance Rights having met the vesting conditions. The Performance Rights were issued on 14 November 2016 as part of the milestones set for Project Jujuy.
