Successful Completion of Institutional Placement

Lend Lease Corporation Limited ("Lend Lease") is pleased to announce that it has successfully completed an institutional placement of 50 million new ordinary shares at \$6.05 per share to raise \$302.5 million in equity.

The placement was well supported by both existing and new shareholders and underscores our focus on maintaining a strong balance sheet and providing the group with flexibility in funding future development activities.

The trading halt that has been in place since Wednesday 4 February 2009 will be lifted at market open this morning.

New shares will settle on Tuesday 10 February and commence trading the following day.
