Correction - Lend Lease Dividend Reinvestment Plan

We refer to the Company's announcements on 15 and 16 September 2008.

The issue price of \$9.357 used to determine the number of shares issued to participants in the Company's Dividend Reinvestment Plan ("DRP") in respect of the final dividend for the year ended 30 June 2008, was incorrect. The correct issue price is \$9.264.

Accordingly, either additional shares have been allotted to those participants or if it is less than one share, the residual amount carried forward to the next dividend payment date on 1 April 2009.

Additional shares were allotted on 12 March 2009 and will be entitled to the interim dividend payable on 1 April 2009 for the half year ended 31 December 2008, and the DRP election instructions will apply to the additional shares.

Attached is an Appendix 3B in respect of the 27,200 additional shares allotted. The total number of shares on issue is 453,892,874.
