**RE: APPENDIX 3B**

Please find attached an Appendix 3B relating to the issue of 50,000,000 fully paid ordinary shares at an issue price \$0.006 on 3 October 2008 pursuant to a Company Share Purchase Plan.

The Plan provided for eligible shareholders to purchase additional tranches of shares up to a maximum of \$5,000 worth at a purchase price of \$0.006.

The Plan was underwritten to \$300,000 by DFS Equities Pty Ltd.

At the close of the offer valid acceptances had been received for 24,833,323 ordinary shares for which subscription funds totalling \$149,000 had been received.

A total of 25,166,677 ordinary shares were issued to the underwriters for which a further \$151,000 in subscription funds was received.

Funds raised were utilised to fund fly ash upgrading test work and to meet the Company's working capital requirements.
