

Notice under Section 708A(5)(e) of the Corporations Act 2001

Lotus Resources Limited (ASX: LOT, OTCQX: LTSRF) (Lotus or the Company) is pleased to advise that it has issued 1,210,524 fully paid ordinary shares in the capital of the Company (**Director Placement Shares**) at an issue price of A\$0.19 per Director Placement Share following completion of the Director Share Placement announced on 4 September 2025 and approved by shareholders on 18 November 2025. The Director Placement Shares were issued under ASX Listing Rule 10.11.

Lotus gives notice under section 708A(5)(e) of the Corporations Act 2001 (Cth) (**Act**) in relation to the Director Placement Shares:
