

Notice Regarding Placement of shares by Montec International Limited

Corporations Act – Placement Exemption

No formal offering memorandum or prospectus has been prepared in connection with the offering of the Placement Shares referred to in the attached Appendix 3B.

The Company's ordinary shares have not been quoted on the securities market operated by Australian Stock Exchange Limited for 12 months, consequently the Company is not able to comply with the conditions of section 708A(5) of the Corporations Act. Accordingly the placement exemption provisions of section 708A do not apply.

The Company is not issuing Placement Shares with the purpose referred to in section 707(3)(b)(i) of the Corporations Act.

There may be restrictions on resale of the Placement Shares without a disclosure document (ie. prospectus) within 12 months of issue (**Relevant Period**) as the Placement Exemption does not apply. Accordingly resale of the Placement Shares may be restricted to:

- persons to whom, or in circumstances when, an offer of securities can be made without a disclosure document under Australian law other than in reliance upon section 708(1); or
- resale under a disclosure document under Australian law.

However, in these circumstances, the Company has not offered any assurances that it would prepare a disclosure document to allow re-sale of the Placement Shares at any time during the Relevant Period.
