**Issue of New Securities
Notice under Section 708A(5)(e) and 708A(6) of the Corporations Act**

On 19 June 2013, Lion Selection Group Limited (**Lion**) announced a placement of approximately 9.4 million shares at 53 cents each to existing and new sophisticated investors to raise \$5.0 million, including all of Lion's directors subject to shareholder approval under ASX Listing Rule 10.11.

Shares with respect to the placement have now been issued and allotted to shareholders other than the Lion directors, and an Appendix 3B in respect of these shares is attached to this notice.

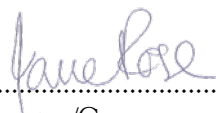
