## Substantial shareholder notice and MA Financial Free Float Analysis

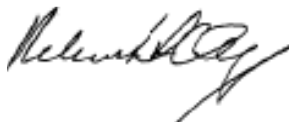

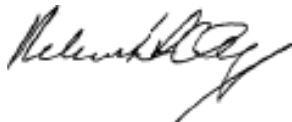

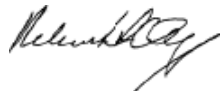
