MANAGEMENT CHANGES

Jumbuck Entertainment Ltd ("Jumbuck") announces two changes to its Senior Management Team.

Jumbuck has committed to a new Executive Service Agreement ("ESA") with Managing Director Europe and Founder of Jumbuck, Adrian Risch. The new ESA replaces the existing service agreement and extends Mr Risch's tenure as Managing Director Europe until December 31st 2008.
