**ISSUE OF PLACEMENT SHARES AND APPENDIX 3B**

SECOS Group Limited (“SECOS” or “the Company”) (ASX: SES) advises that it has today settled the \$1,043,086 placement announced by the Company on 29 August 2016.

A total of 12,720,562 ordinary shares have been issued as a result of the placement. 9,988,068 ordinary shares were issued pursuant to the Company’s placement capacity available under Listing Rule 7.1 and balance 2,732,494 Ordinary shares were issued pursuant to the Company’s placement capacity available under Listing Rule 7.1A

The Company provides the following information in accordance with ASX Listing Rule 3.10.5A

- a) Dilution to existing shareholders:

The dilutive effect of the placement on existing shareholders is as follows:

- b) SECOS considered the Placement as the most efficient and expedient method for raising the funds required for capital expansion and general working capital requirements. SECOS also considered that there were significant benefits in introducing new investors to promote a more diverse shareholder base. SECOS also considered that the Company had completed capital raising via Share Purchase Plan and Share Placement in March 2016.
- c) No underwriting agreements were in place for the Placement.
