NEW SHARES ISSUED ON CONVERSION OF CONVERTIBLE NOTES AND SECTION 708A(5)(E) NOTICE

SECOS Group Limited ("SECOS" or "the Company") has issued **1,851,852** fully paid ordinary shares ("Shares") to convertible note holders on **10 September 2019** pursuant to Convertible Notes Deed entered into on 30 November 2017.

This issue has resulted in a further reduction of the Company's debt to \$0.65 million, \$0.35 million of which is convertible notes outstanding.

The issue of the Shares was approved by shareholders at the Annual General Meeting held on 30 November 2018. The shares are issued at an issue price of \$0.054/share. The share issue price was based on 10-day VWAP discounted by 15% pursuant to Convertible Notes Deed.

In respect of the issue of shares, the Company gives notice pursuant to section 708A(6) of the *Corporations Act 2001* (Cth) ("Corporations Act") that:

- (a) the Shares were issued without disclosure to investors under Part 6D.2 of the Corporations Act;
- (b) this notice is given under section 708(5)(e) of the Corporations Act;
- (c) as at the date of this notice, the Company has complied with:
 - i. the provisions of Chapter 2M Corporations Act as they apply to the Company; and
 - ii. section 674 of the Corporations Act; and
- (d) as at the date of this notice, the Company is not aware of any 'excluded information' within the meaning of sections 708A(7) and 708A(8) of the Corporations Act to be disclosed under section 708A(6)(e) of the Corporations Act.
