ISSUE OF SHARES TO DIRECTORS IN LIEU OF CASH REMUNERATION AND SECTION 708A(5)(e) NOTICE

SECOS Group Limited ("SECOS" or "the Company") has issued **703,035** fully paid ordinary shares to its directors, Mr Richard Tegoni, Mr Donald Haller Jnr., Mr David Wake and Mr Jim Walsh in lieu of the cash payment of their respective remuneration for the period between October 2019 to December 2019.

The Directors have resolved that all directors shall be paid their directors' fee by new shares in lieu of cash to preserve cash for working capital purposes. This was approved by shareholders (resolution 9, 10, 11 and 12) in Annual General Meeting held on 22 November 2019.

The shares are issued at an issue price based on quarterly volume weighted average price of SECOS shares for the quarter. The average price was **\$0.089/share**.

In respect of the issue of shares, the Company gives notice under section 708A (5)(e) of the Corporations Act that;

The abovementioned shares were issued without disclosure to investors under Part 6D.2 of the Corporations Act;

The Company also state, that as at the date of this notice:

- it has complied with the provisions of Chapter 2M Corporations Act as they apply to the Company; and section 674 Corporations Act; and
- it is not aware of any excluded information within the meaning of Sections 708A(7) and 708A(8) of the Corporations Act.
