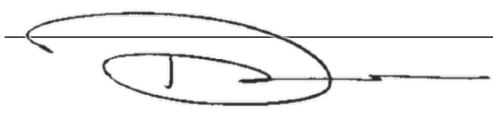

## DIRECTIONS
