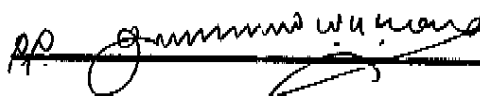

DIRECTIONS

Notes:

On 21 November 2014, Ms. Chong Sok Un ("**Ms. Chong**") held approximately 73.65% interest in COL Capital Limited ("**COL**") and COL through certain of its subsidiaries held approximately 33.32% interest in APAC Resources Limited ("**APAC**"). APAC and its related body corporates held approximately 26.61% interest in MGX (the "**MGX Shares**"). Therefore, COL and its subsidiaries and Ms. Chong have a deemed relevant interest in the MGX Shares.

COL announced on 21 November 2014 that it declared a special interim dividend to be satisfied by way of a distribution in specie of the shares of APAC held by COL and its subsidiaries in the proportion of 3.75 APAC Shares for every 1 COL share held by the COL shareholders (the "**Distribution**")

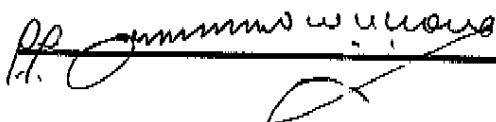
As a result of the Distribution made on 24 December 2014, COL's interest in APAC reduced to 0.87% and Ms. Chong's interest in APAC (including deemed relevant interest via COL) decreased to 24.80%.
