METAL HAWK FURTHER CONSOLIDATES BEREHAVEN NICKEL PROJECT (AMENDED)

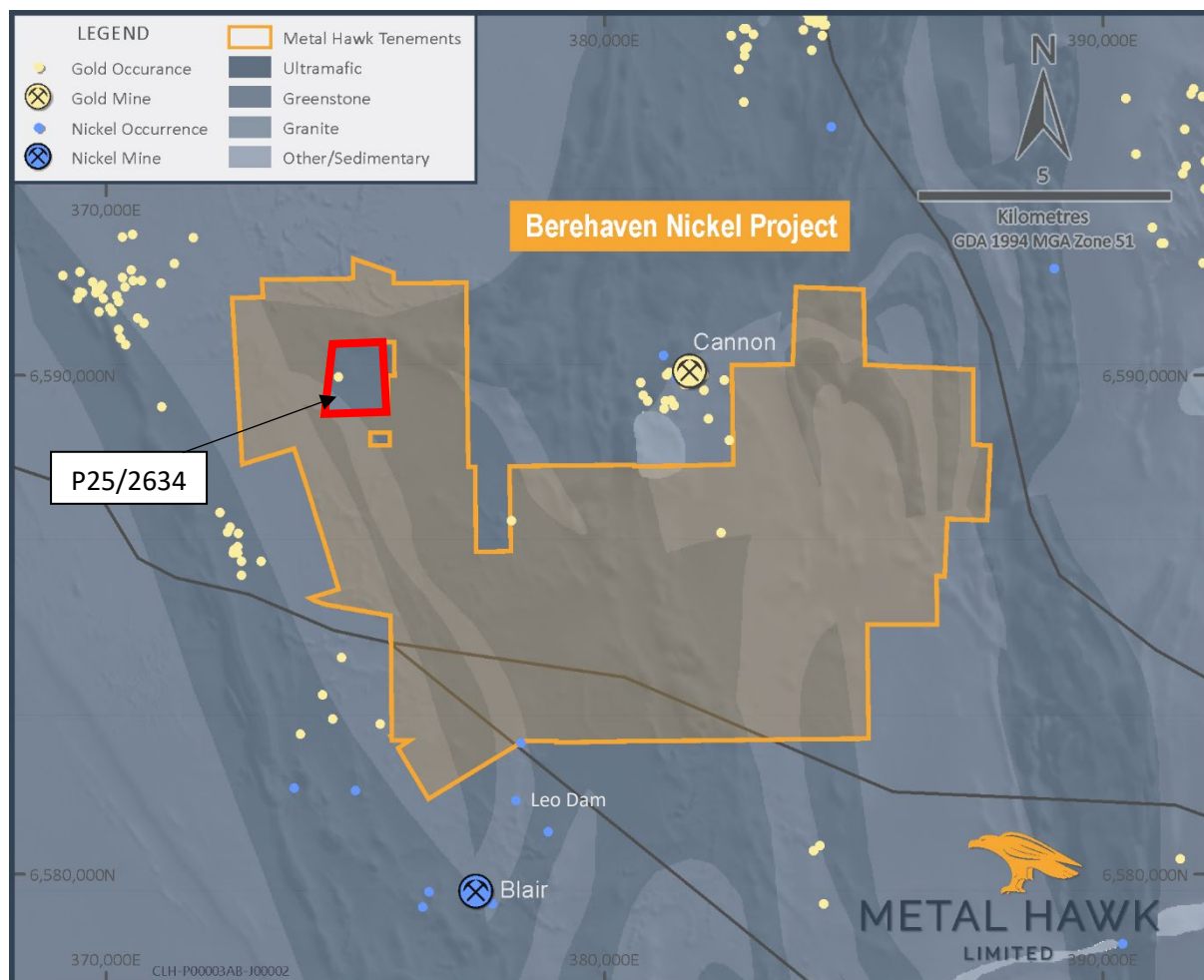


Figure 1a. Berehaven Nickel Project - P25/2634 (shown in red) is located approximately 7km west of the Cannon gold mine

Metal Hawk Limited (**ASX: MHK**, “Metal Hawk” or “The Company”) is pleased to announce that it has purchased the Snake Hill tenement P25/2634 which is located within the Company’s Berehaven Nickel project (Figures 1a and 1b), approximately 20 kilometres east of Kalgoorlie. The tenement is prospective for nickel and gold, with recent alluvial gold discovered by prospectors at Snake Hill (shown in Figure 2).

The tenement, which covers 171.4 hectares, was purchased for a sum of 200,000 fully paid MHK shares from a local Kalgoorlie prospector who will retain the alluvial gold rights on the lease for a further 12 months. Metal Hawk’s Managing Director Will Belbin commented: “We are pleased to have secured this key tenement prior to commencing regional exploration on the Berehaven Nickel Project. Exploration plans are progressing well with RC drilling to commence shortly.”

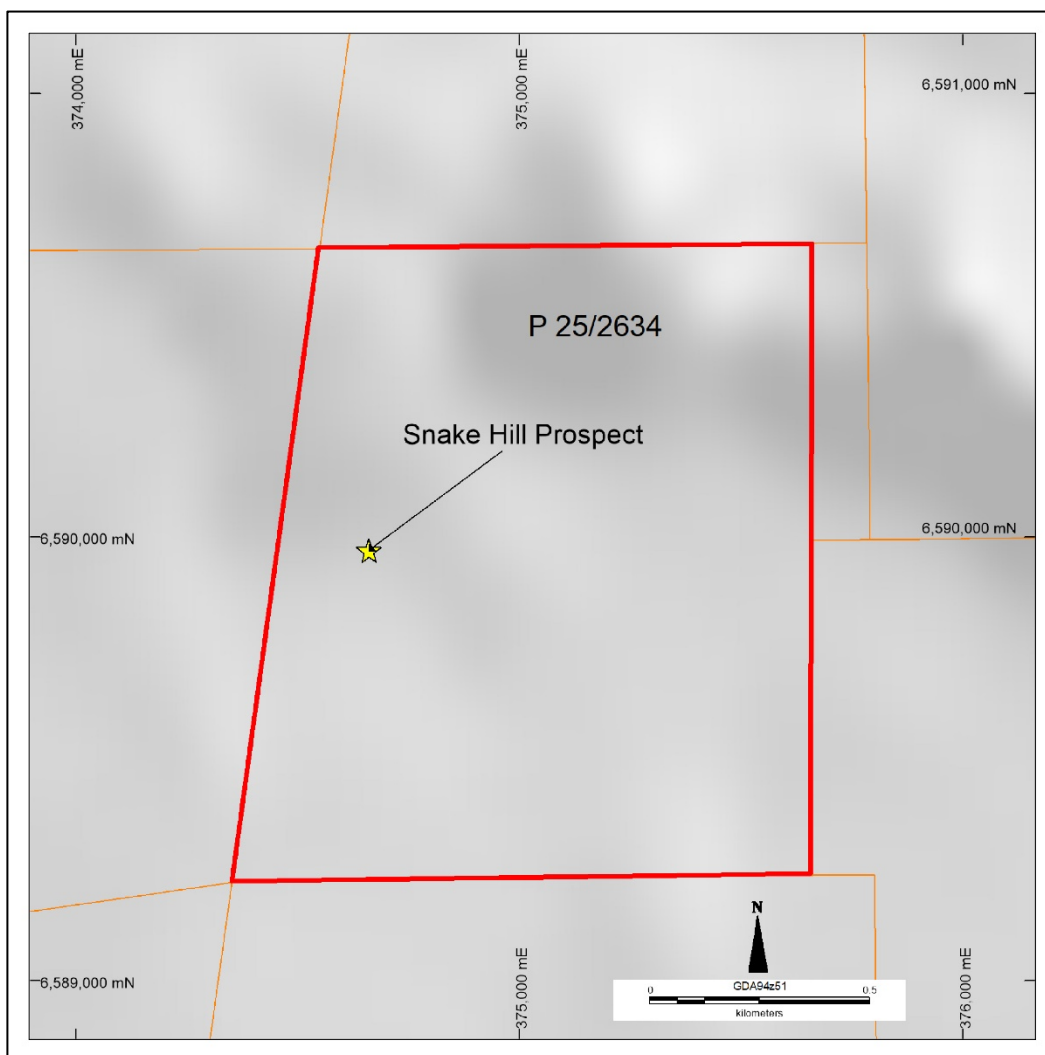


Figure 1b. Tenement P 25/2634 showing the location of the Snake Hill Prospect.
