DRILLING COMMENCES AT LEINSTER SOUTH

Metal Hawk Limited (ASX: MHK, “Metal Hawk” or the “Company”) is pleased to advise that drilling has commenced at its 100% owned Leinster South Project, located in the world-class Agnew-Lawlers region, Western Australia.

Metal Hawk’s Managing Director Will Belbin commented: *“We have been looking forward to drilling at Leinster South since the first assay results of high-grade gold were returned from Siberian Tiger in August last year. This is the first ever drilling undertaken at both the Thylacine and Siberian Tiger prospects, which are two of the most exciting early-stage gold targets in Western Australia. We will be updating investors with results as soon as possible.”*

Since discoveries of high-grade gold at Leinster South in 2024, Metal Hawk has been preparing for the maiden drilling campaign which is now underway. Reverse circulation (RC) drilling has commenced at Thylacine, where initial holes are planned to intercept the stacked and steeply dipping gold-bearing quartz veins at shallow depths. Extensive drilling is also planned at Siberian Tiger.

First assay results are expected in late-July.

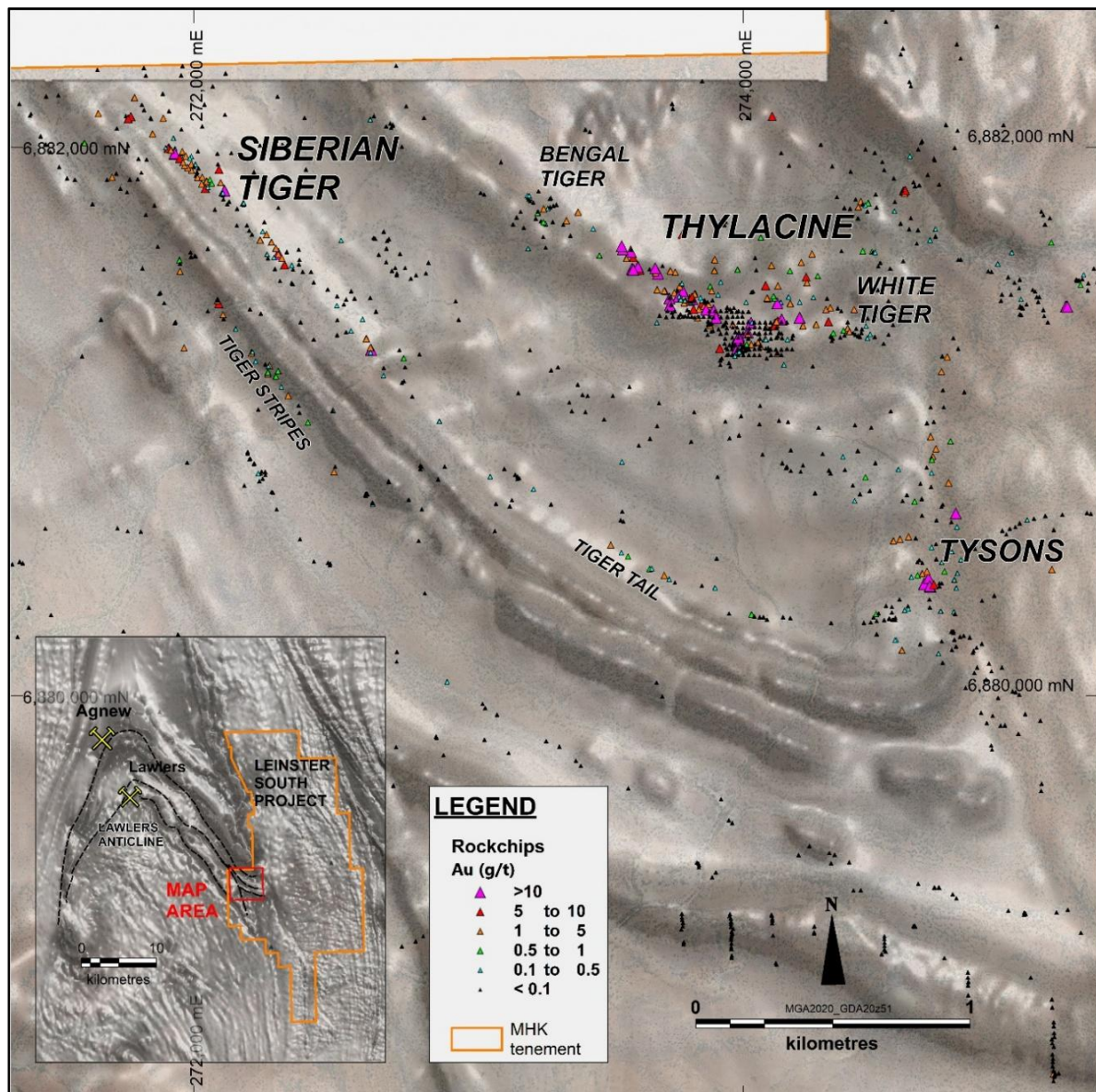


Figure 2. Leinster South project; main prospects, rock chip results, magnetics (TMI)

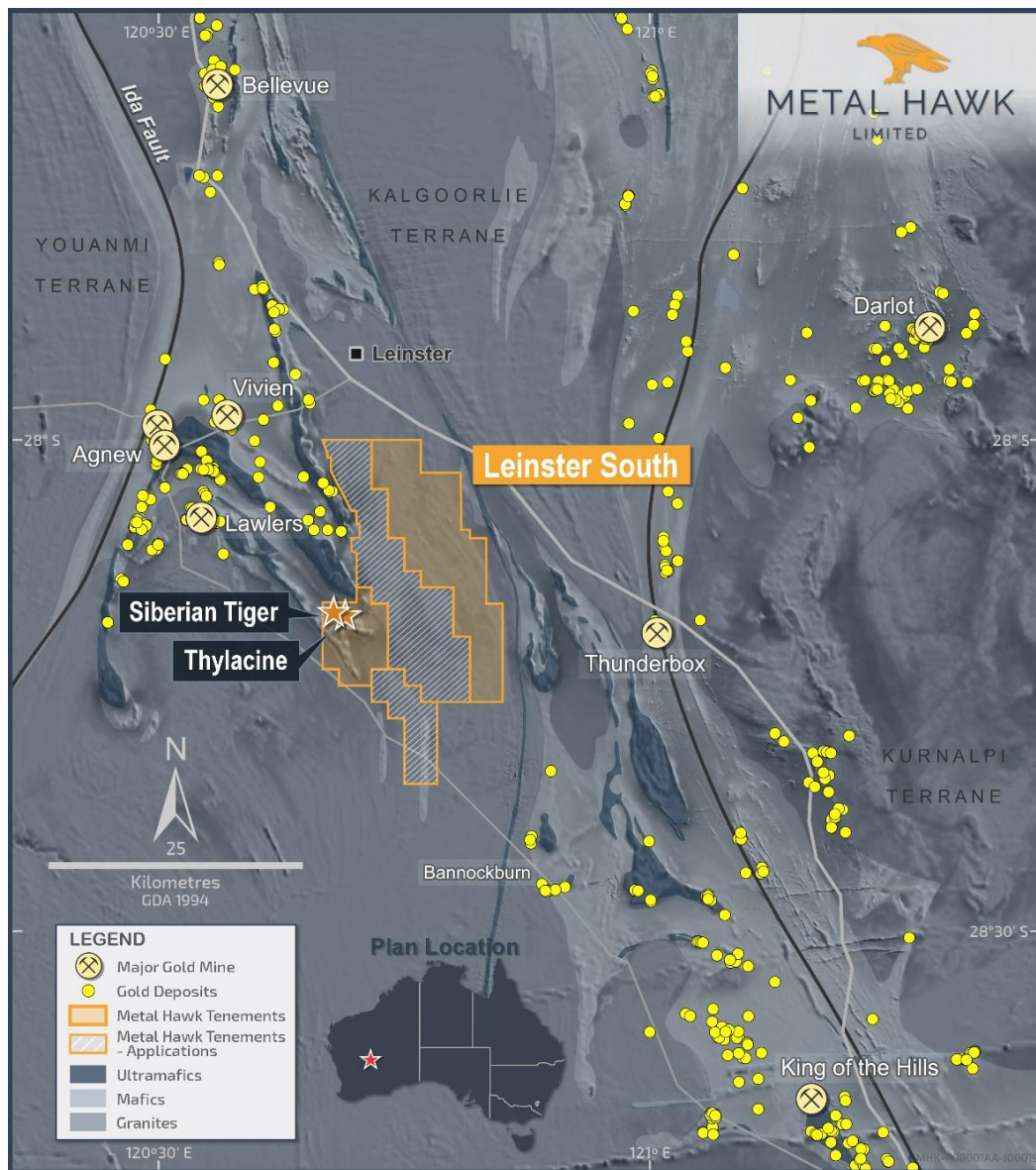


Figure 3. Leinster South Project
