

ISSUE OF SHARES AND CLEANSING NOTICE

Further to its ASX announcement on 20 May 2025 and following shareholder approvals at the General Meeting on 9 July 2025, Midas Minerals Ltd ("Midas", or "the Company") (ASX: MM1) has today issued 12,313,415 fully paid ordinary shares ("Shares") at an issue price of \$0.15 each under the second tranche of the Placement, raising approximately \$1.85 million (before costs).
