
**REQUEST FOR VOLUNTARY SUSPENSION**

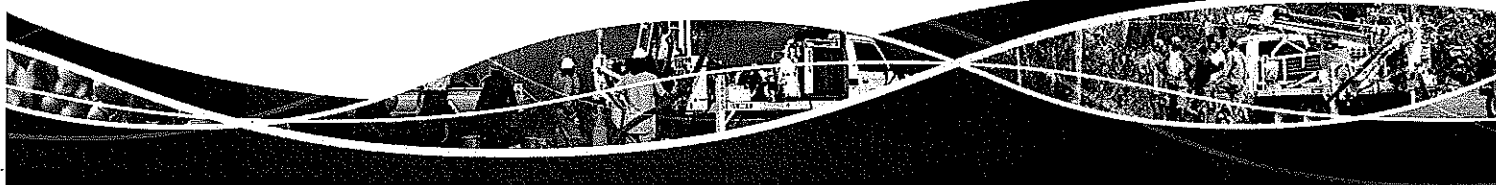
