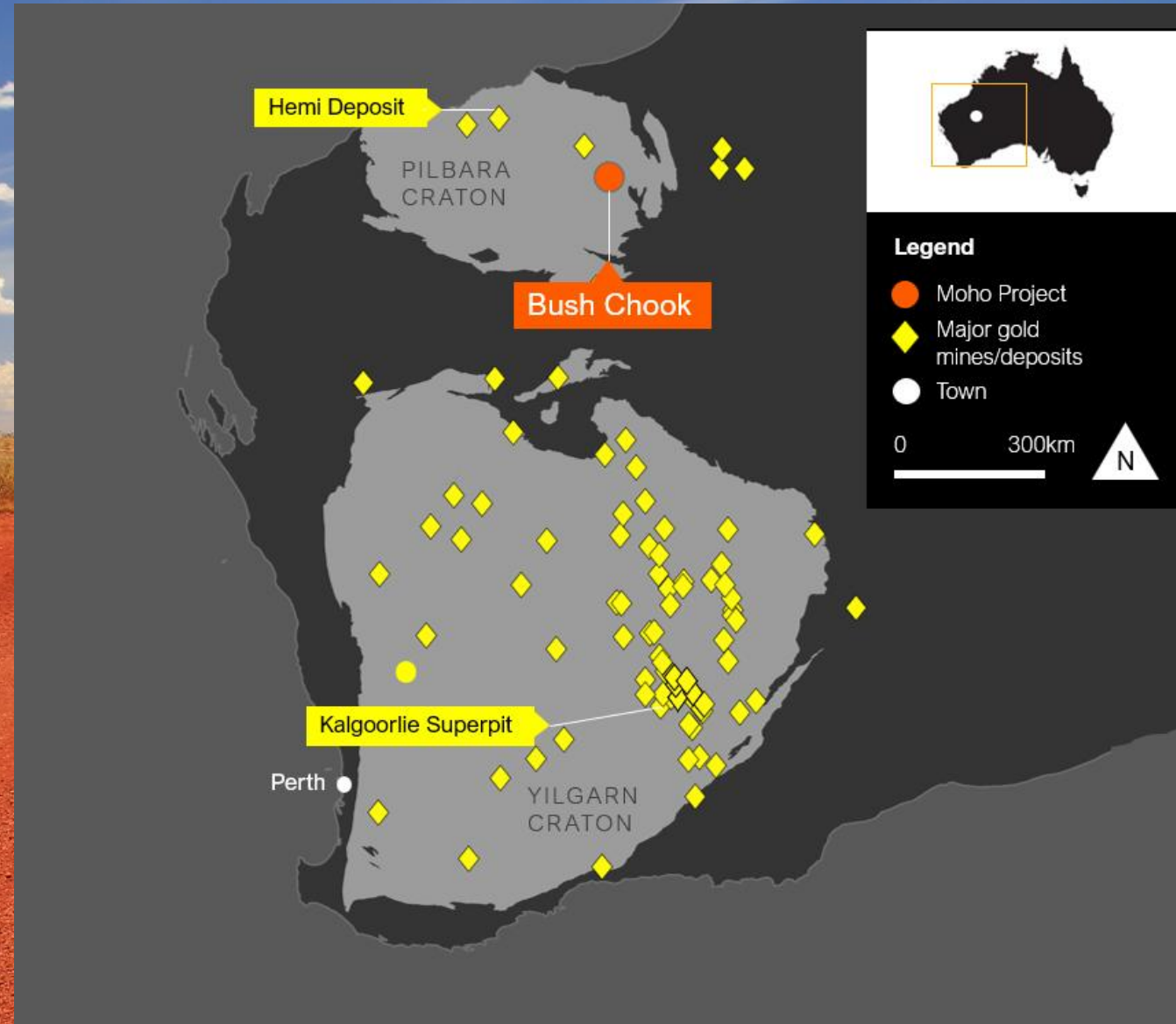

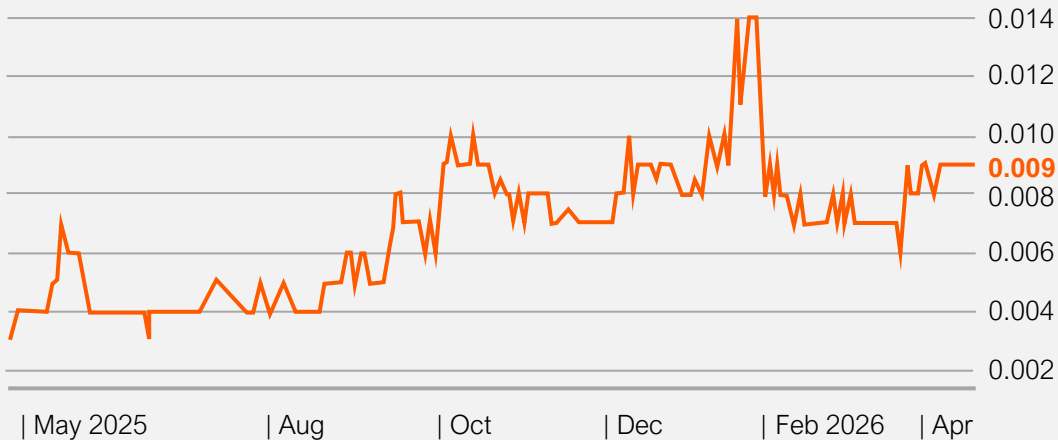

THE BUSH CHOOK GOLD PROJECT TICKS THE RIGHT BOXES.



Land Position Large 442km² land position in a highly-endowed gold belt in the Pilbara, Western Australia.



Geology Mosquito Creek Basin is a 2.5Moz* gold belt with striking geological similarities to the Mallina Basin – host to Northern Star's 11.2Moz Hemi Gold Deposit.



Infrastructure Adjacent to Mark Creasy's Nullagine and Blue Spec Projects with a 1.8Mtpa gold plant.



Historic Mine Rocky Ridge mine produced 932oz from 341t at 85g/t Au, with mineralisation open down dip and along strike[^].



Blue Spec Analogue Narrow high-grade Au-Sb shear at Rocky Ridge shows comparable geometry, grade style and antimony association.



Aggressive Exploration A 5,000m RC program is scheduled to begin in May.

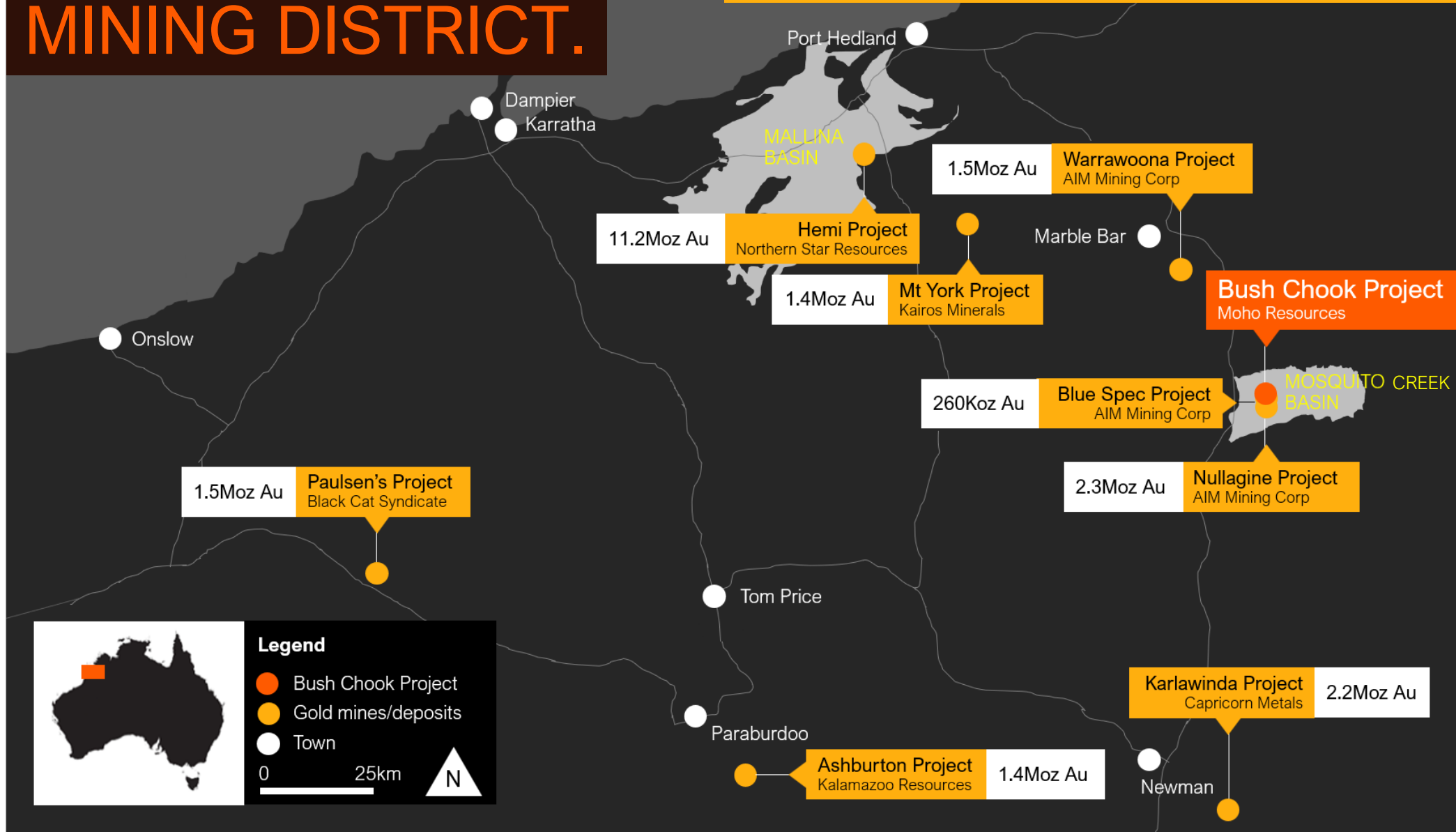

Western Australia's Pilbara region is known for multiple mines including the 11.2Moz Hemi Gold Project*.

NEXT DOOR TO CREASY'S AIM MINING CORP.

- Bush Chook surrounds Mark Creasy's underground operations and processing plant.
- The Nullagine Project has produced 671Koz of gold since 2012*.
- Bush Chook is within 40km radius of the 1.8Mtpa Golden Eagle Mill.
- The high-grade Blue Spec Gold-Antimony Deposits (260Koz) has produced over 60,000oz of gold at an average grade in excess of 25g/t.
- AIM is actively developing three underground mines and refurbishing the process plant ahead of a planned restart.
- The recently acquired Rocky Ridge prospect contains high-grade "Blue Spec look-a-like" gold-antimony targets just 10km from Blue Spec.

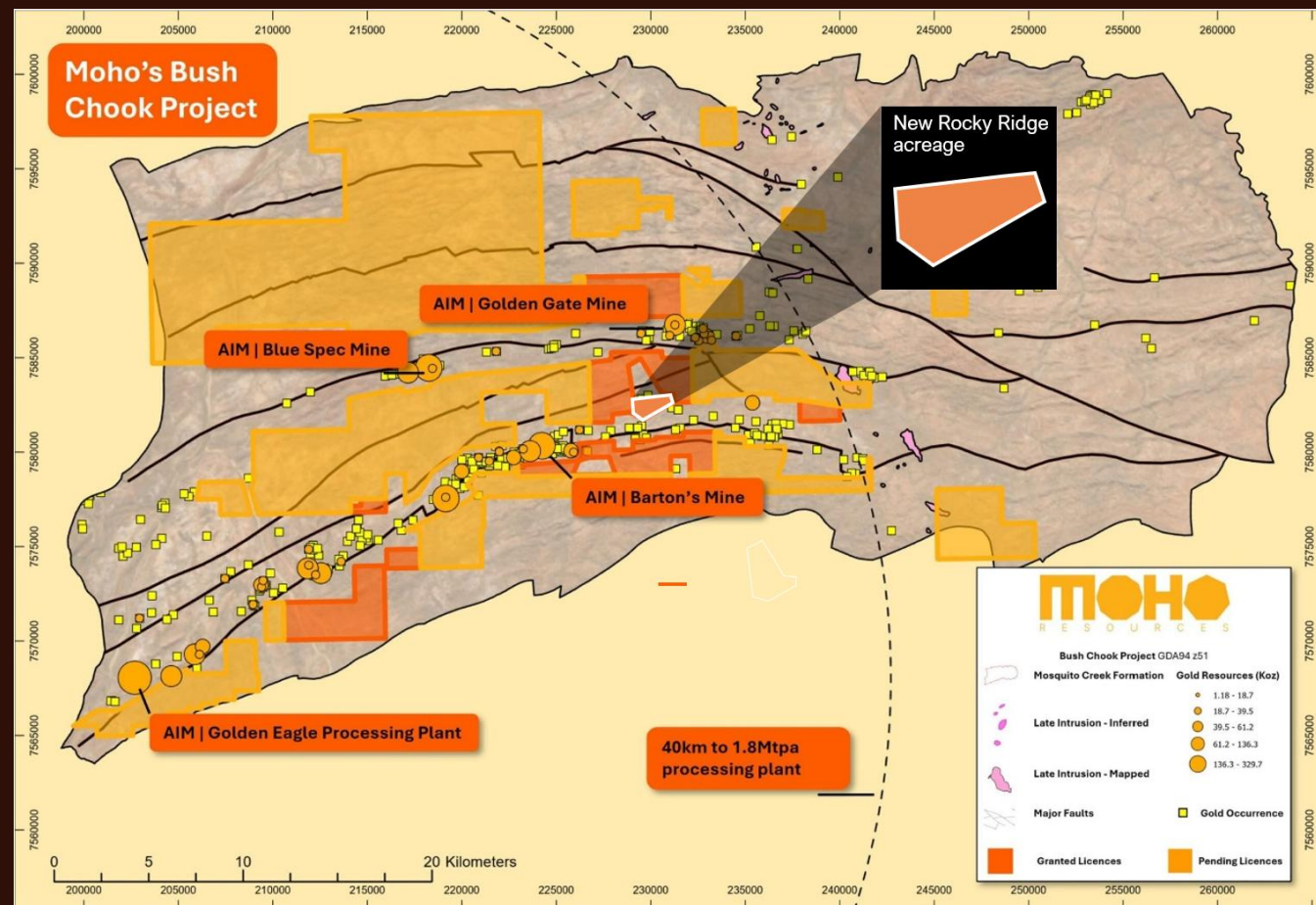

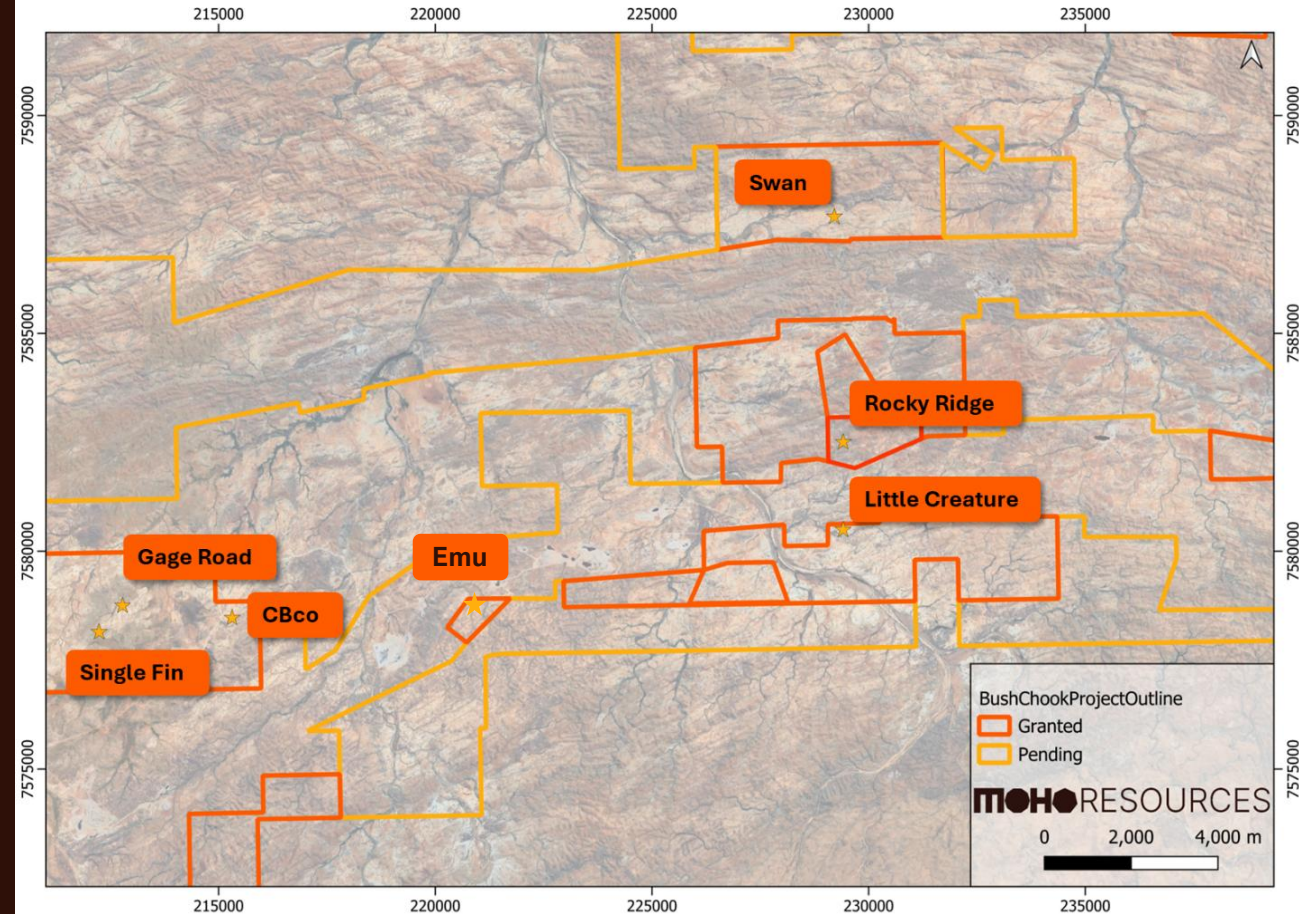


TWO PHASES OF EXPLORATION IN 2026

● **Phase One Program**
5,000m RC program will focus on priority on the granted licences.

● **High impact targets**
high grade mineralisation in underground workings and at surface.

● **Phase Two Program**
to refine and test drilling targets on the broader land package.

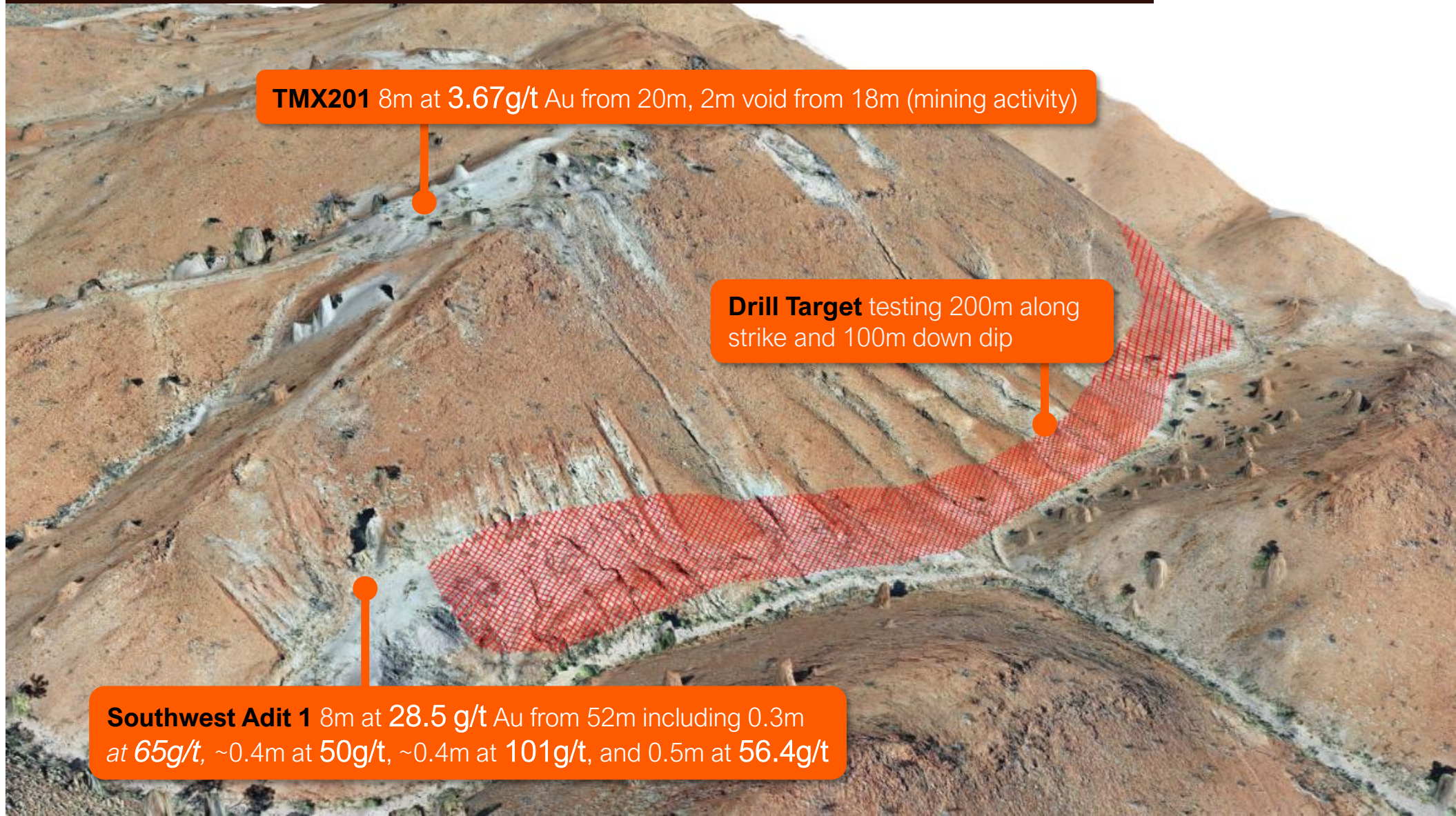


A 5,000M RC PROGRAM IS DRILL-READY FOR MAY.

- A specialised track-mounted RC rig is secured for the steep Rocky Ridge terrain.
- Versatile drilling angles will ensure the targets get tested
- Minimal earthworks and environmental disturbance
- 4,000 soil sample program began on 12 March – ongoing target generation to identify tomorrow's priority targets

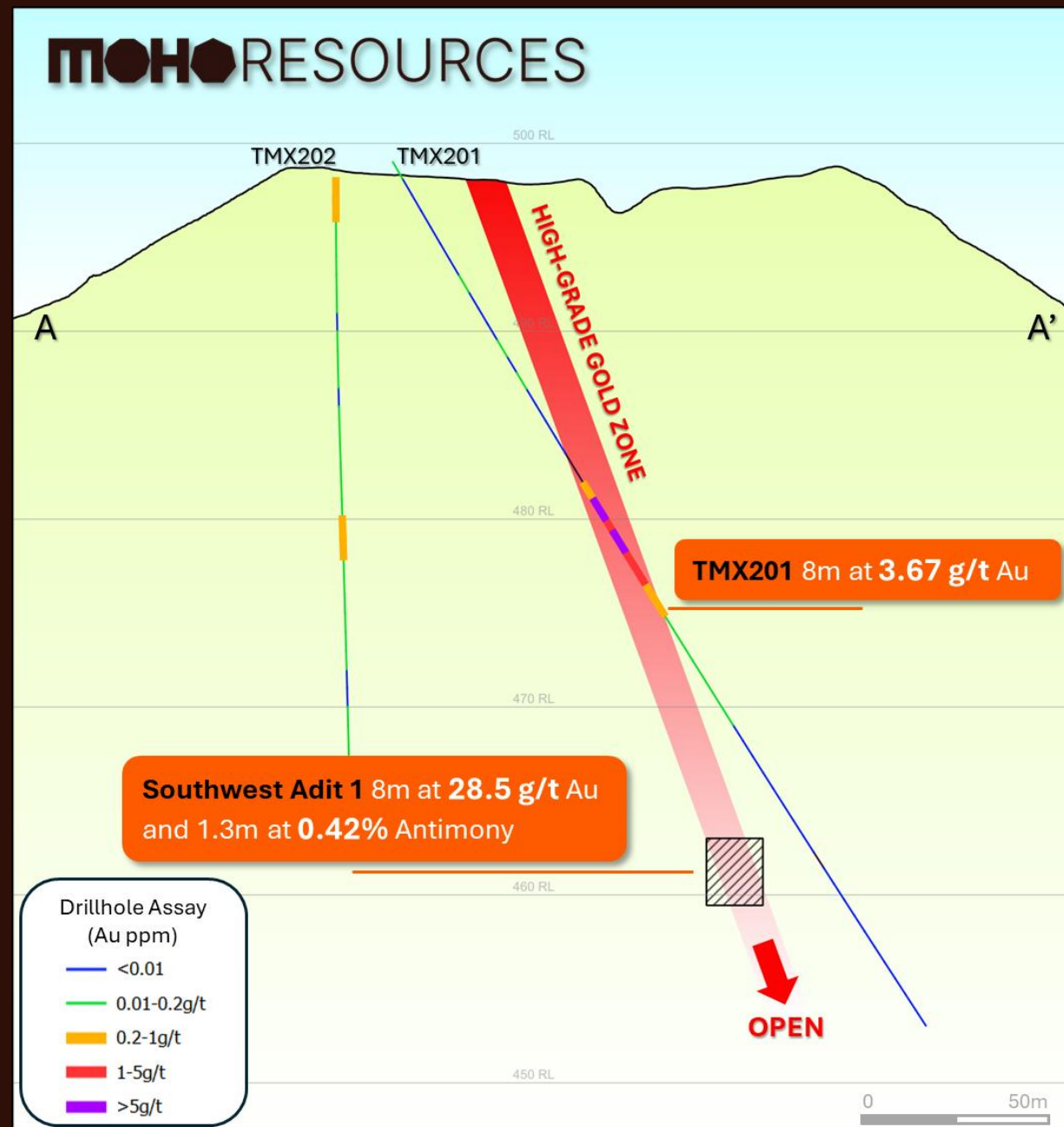
**Isometric view of the Rocky Ridge Prospect looking southwest

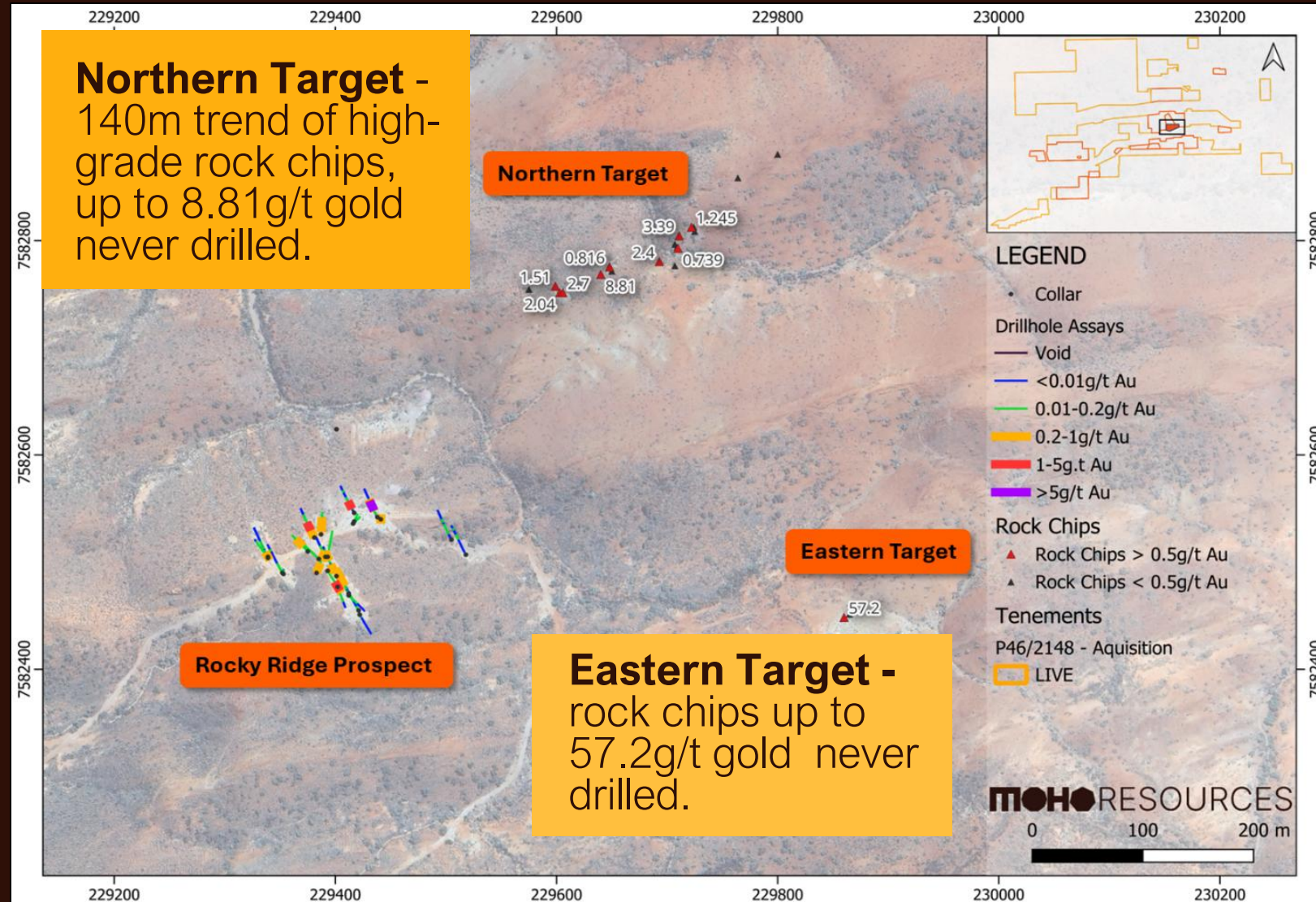

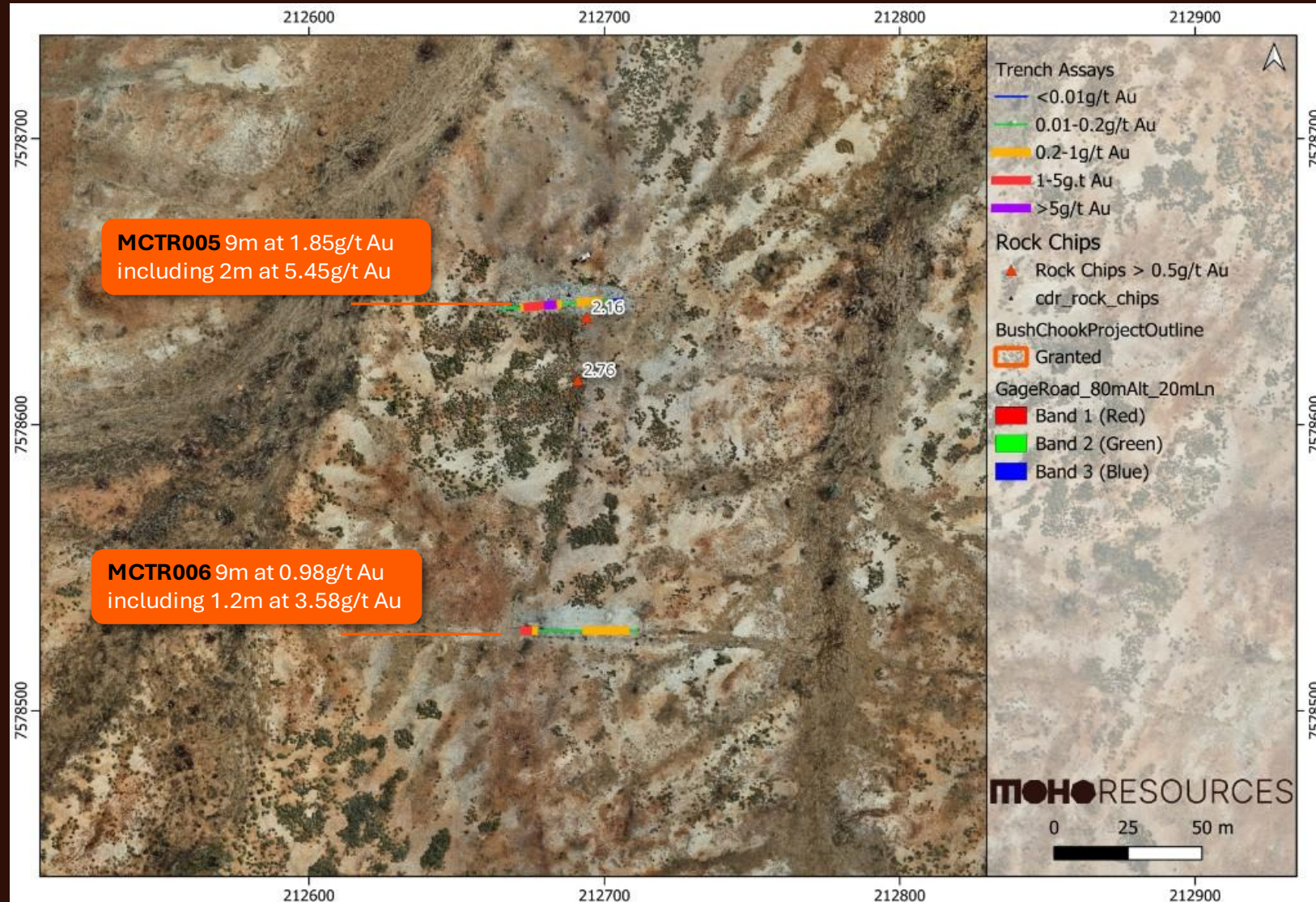

NORTHERN AND EASTERN TARGETS ADD NEAR-TERM UPSIDE.



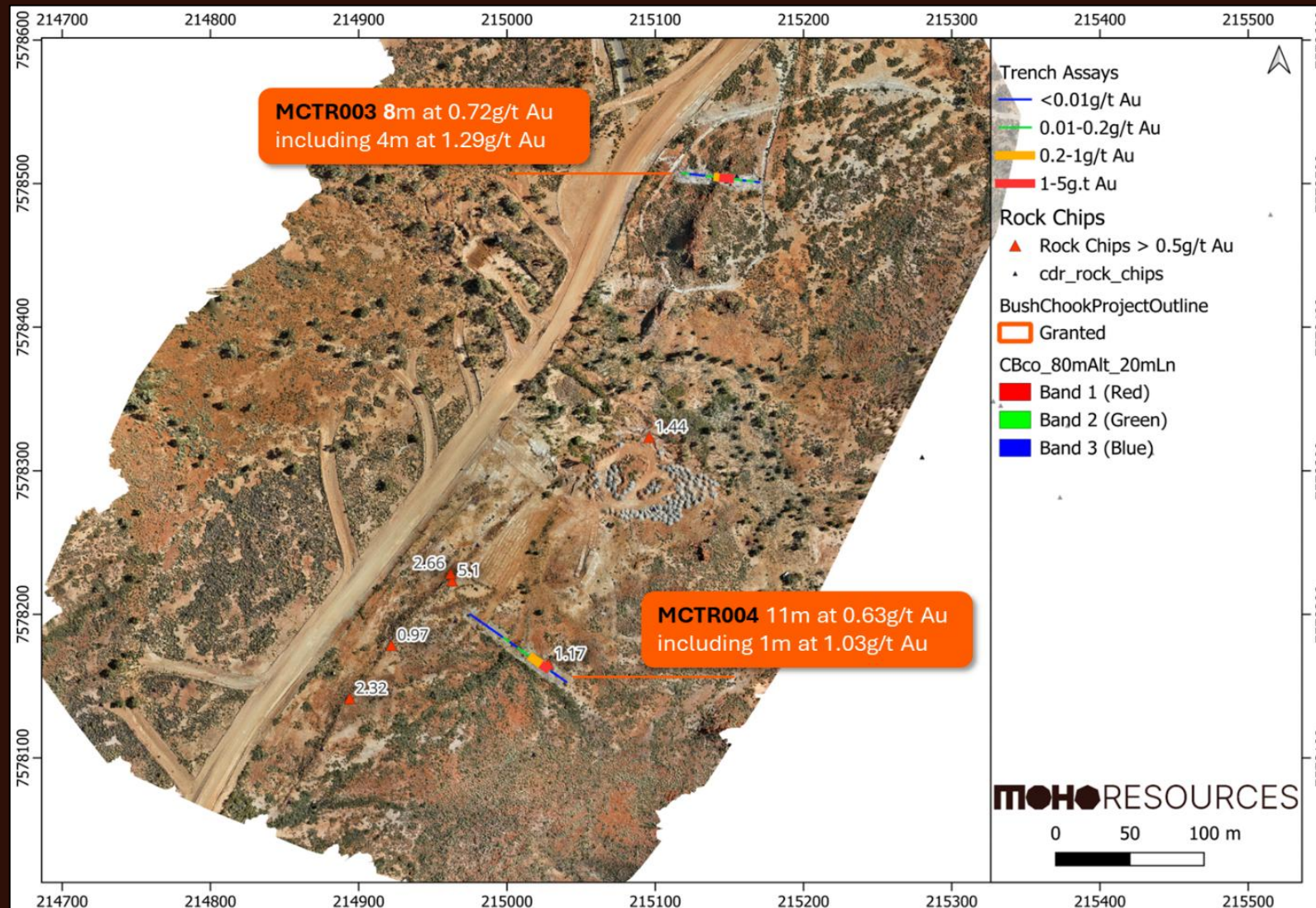

GAGE ROAD: GOLD MINERALISATION DEMONSTRATED OVER 115M.



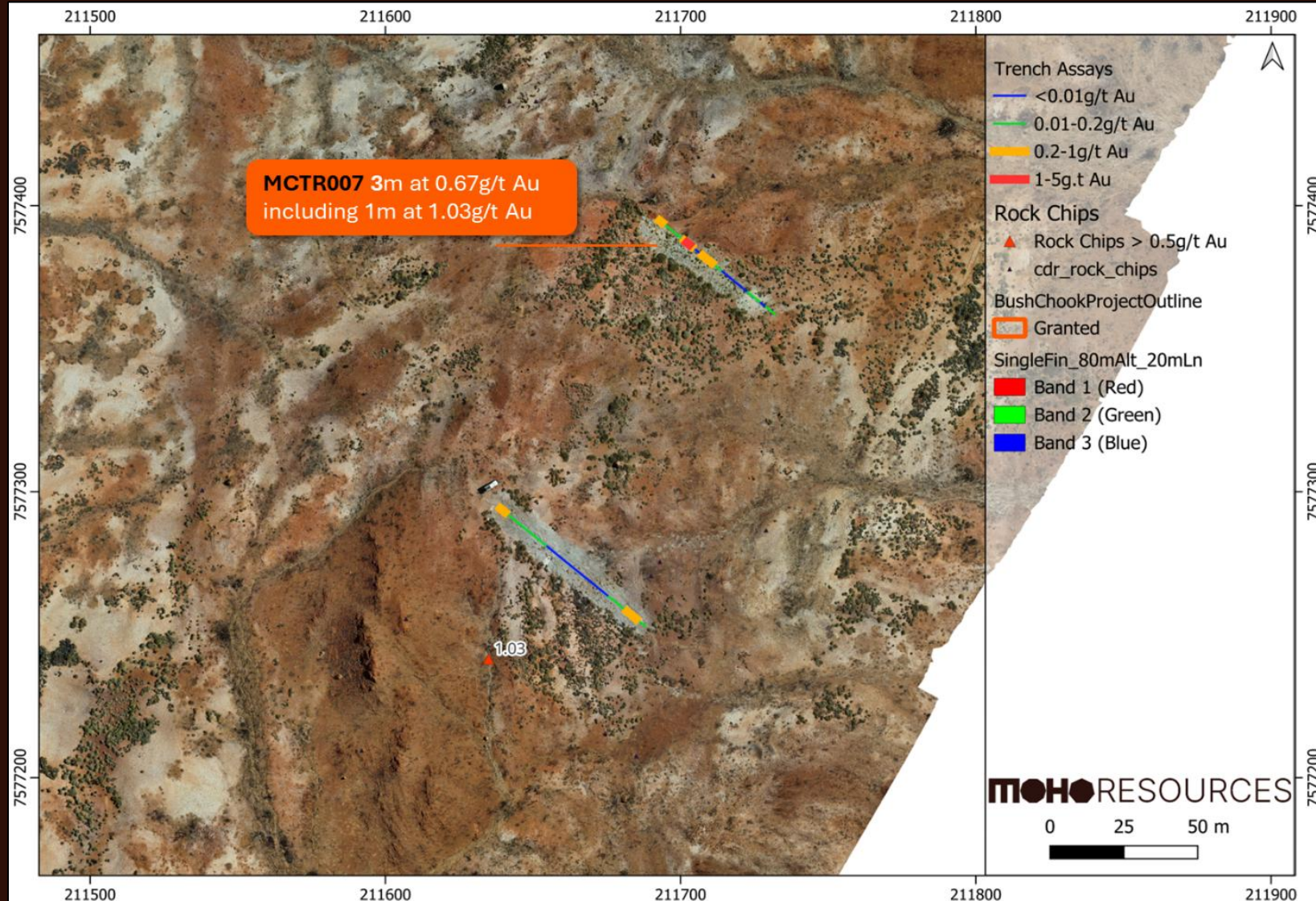
