Appendix 3Y Correction

Megaport Limited (**Megaport** or **Company**) (**ASX:MP1**) wishes to advise a correction to the Appendix 3Y released on 2 October 2024.

The Appendix 3Y lodged on 2 October 2024 incorrectly noted that the number of securities held prior to the change was 11,000 fully paid ordinary shares, when in fact the correct number was 13,009. This error flowed through to the number of securities held after the change. The number acquired (3,000 fully paid ordinary shares), the consideration and date of change were noted correctly.
