NOTICE UNDER SECTION 708A(5)(e) OF THE CORPORATIONS ACT 2001

This notice is given by **Mount Ridley Mines Limited** (ASX: MRD) (or “the **Company**”) pursuant to section 708A(5)(e) of the Corporations Act 2001 (Cth) (“Corporations Act”).
