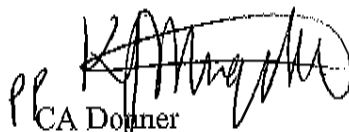

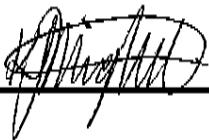

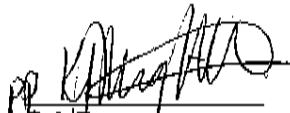
DIRECTIONS
