Leung) to enable it to complete the acquisition of the Verdicorp assets and, shareholders have approved to grant security to Super Link Company Ltd of its interests in the assets acquired under Verdicorp Acquisition, at the Company's AGM on 12 May 2023. The loan is interest bearing at 5.00% per annum. Multistack Australia Pty Ltd has borrowed A\$696,000 from ACR Equipment (HK) Ltd (a related party of S. Yan and S. Leung) in the prior periods, this loan is non-interest bearing and unsecured.

Answer: The entity will continue its principal business activities being the sale, marketing and distribution of Multistack water-cooled and air-cooled water chillers.

The entity has also secured both access to and control of the ORC technology and products which complements its existing modular chiller business and in an area in which the directors believe has significant future growth potential.
