ASX ANNOUNCEMENT

Cleansing Notice Under Section 708A of The Corporations Act

Further to the announcement Wednesday, 8 August 2018, Medical Developments International (ASX: MVP) (**Company**) advises that it has today successfully completed a placement of 4,250,000 fully paid ordinary shares in the Company (**Placement Shares**) to a number of sophisticated and wholesale investors at a price of \$4.00 per fully paid ordinary share, raising \$17 million (before costs).

As announced on 8 August 2018, MVP will invite shareholders on the MVP share register at 7.00pm (AEST) on Tuesday, 7 August 2018 (**Eligible Shareholders**) to invest in the Company through a Share Purchase Plan (**SPP**) at a purchase price of \$4.00 per fully paid ordinary share. Further information in relation to the SPP, including the SPP terms and conditions, will be outlined in the SPP offer document to be despatched to Eligible Shareholders by Wednesday, 22 August 2018.

For the purpose of section 708A(5) of the *Corporations Act 2001* (Cth) (**Corporations Act**), the Company hereby gives notice to the ASX that:

- (a) the Placement Shares were issued without disclosure to investors under Part 6D.2 of the Corporations Act;
- (b) this notice is being given under paragraph (5)(e) of Section 708A of the Corporations Act;
- (c) as at the date of this notice, the Company has complied with:
 - (i) the provisions of Chapter 2M of the Corporations Act as they apply to the Company; and
 - (ii) Section 674 of the Corporations Act; and
- (d) as at the date of this notice, there is no information that is 'excluded information' (within the meaning of Sections 708A(7) and 708A(8) of the Corporations Act).
