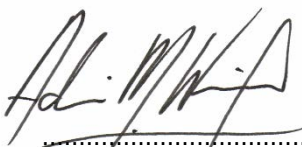

The percentage of the Company's issued capital represented by the issue under ASX Listing Rule 7.1A is 8.01%. 45,085,733 of the placement shares were issued under 7.1A per this issue. The holders of ordinary shares before the issue under ASX Listing Rule 7.1A will hold 91.99% of the issued capital following the issue under of Listing Rule 7.1A.

The Company conducted the placement rather than a pro-rata issue or other type of issue in which existing security holders would have been eligible to participate as it was considered a more efficient and expedient manner to raise capital given the Company's circumstances.
