Issue of Shares and Forfeiture of Performance Rights and Options

We advise that 181,434 **Performance Rights (NANAO)** have been exercised (167,344 Performance Rights under the Nanosonics Omnibus Equity Plan and 14,090 Performance Rights under the Nanosonics Employee Share Option Plan). Accordingly, **181,434 Fully Paid Ordinary Shares** have been issued. In addition, 14,540 Performance Rights (NANAO) and 54,381 Options (NANAB) were forfeited under the Nanosonics Omnibus Equity Plan. There is now a total of 3,856,539 unlisted Options and Performance Rights on issue. These movements in securities are detailed in the attached Appendix 2A.
