Share Placement - Notice under section 708A(5) of the Corporations Act 2001

On 6 March 2008 the Company issued 13,245,034 fully paid ordinary shares (**New Shares**) at an issue price of A\$15.10c per share pursuant to an institutional equity placement to raise A\$200 million.
