SUBJECT: COPERNICUS JV – DRILL RESULTS

- Drill results for six recently completed reverse circulation in-fill drill holes;
- All six holes intersect nickel sulphide mineralisation;
- Best drill hole intersection is 7 metres at 1.44% nickel, 0.86% copper and 0.06% cobalt;

COPERNICUS DRILLING RESULTS

Sally Malay Mining Limited (ASX Code: SMY) is pleased to report the remaining assay results from the recent drill program at the Copernicus Joint Venture with Thundelarra Exploration Limited (Sally Malay earning 60%) located 35km south of the Sally Malay Project.

The Company recently completed six reverse circulation holes into the Copernicus Prospect (current resource is 241,000t @ 1.5% nickel, 0.8% copper and 0.059% cobalt using a 1% nickel cut-off) to better define the resource extension to the south and at depth. Assay results for the six drill holes are summarised below:

The above results confirm the earlier interpretation of the Copernicus Prospect. Feasibility study work on the Copernicus Prospect will commence in 2004 as will a follow-up drill program over the adjacent Copernicus North EM anomaly where the Company recently reported a 3 metre massive sulphide intersection grading 2.75% nickel, 1.36% copper and 0.083% cobalt.
