Grant of Performance Rights

The Company has today granted 1,175,074 Performance Rights to an eligible employee pursuant to their employment agreement. The Performance Rights may vest on 30 June 2017 or 31 December 2017 on the satisfaction of certain performance conditions, based on the Company's total shareholder return performance and percentile ranking relative to comparator companies.

The Company has also issued 49,274 ordinary shares following the vesting of existing employee Performance Rights.
