Unsecured Loan Facility: As announced to the market 30 April 2020 NewPeak Managing Director David Mason and former Director Neil Stuart indicated their willingness to provide short-term funding for the Company if required. To date David Mason has provided \$182,374 in short-term funding. No short-term funding has been provided by Neil Stuart. Interest will be accrued at 9% per annum, as announced on 20 July 2020. <i>At the Company's 2020 AGM (convened in January 2021) approval was provided by shareholders for the conversion of the above loan to shares in the Company, in accordance with the formula contained in the Notice of Meeting.</i> Other (Unsecured Converting Note): The principal terms of the Converting note are as follows: Amount: \$560,000 Interest Rate: 12% per annum Interest Payments: Interest payable quarterly in arrears Maturity Date: 1 May 2021 Repayment Terms: The Company may repay the loan either via shares or cash. If the Company elects to repay the loan via the issue of shares, the issue price of the shares will be the higher of A\$0.003 or 10% discount to the 30 day VWAP ending on the business day prior to the date of payment.
