Placement Completed

On 25 August 2010 SmartTrans Holdings Ltd announced that it was in the process of making a placement of up to 9,999,997 ordinary shares in the Company at \$0.017 each to raise up to \$170,000 (**Placement Shares**).

SmartTrans Holdings Ltd confirms that the placement has now been completed and the Company has today issued 9,999,997 ordinary shares in the Company.
