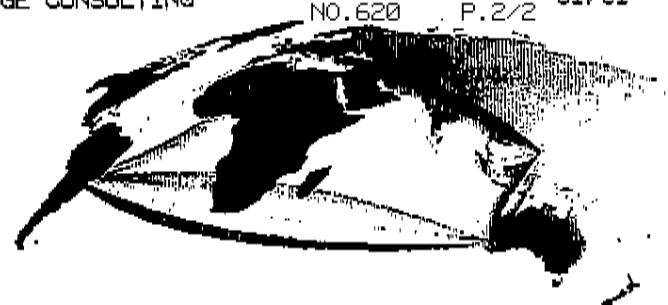

REQUEST FOR TRADING HALT
