Notes:

- (1) The Company's investment in Bentley Capital Limited (ASX:**BEL**), an Associated Entity (i.e. in which the Company has a greater than 20% interest), is accounted for under the equity method in the consolidated financial statements. Under the equity method, the carrying amount of such investment is cost plus a share of the Associate Entity's net profit or loss (after tax) for the financial year to month end as provided to the Company by such Associated Entity. Refer also Note 20 (Investments in Associates) on pages 37 and 38 of the Company's 30 June 2020 Annual Report for further details in this regard.

Accordingly, as at 31 October 2020, the Company's 20,513,783 shares (26.95% interest) (30 September 2020: 20,513,783 shares and 26.95%) in BEL have a \$0.762m carrying value; this compares with BEL's last bid price on ASX of \$0.051 per share (\$1.046m) and BEL's after-tax NTA backing of \$0.0973 per share (\$1.996m)¹, as at month end.

- (2) The fair value of investments in ASX-listed Strike Resources Limited (ASX:**SRK**) comprise 10,000,000 shares (30 September 2020: 10,000,000 shares) with a value of \$0.088 per share (based on the closing bid price as at 31 October 2020) (30 September 2020: \$0.115).
- (3) The fair value of investments in other listed securities is based on each security's last bid price on market at month end.
- (4) The fair value of Investment in property (held for resale) is based on the Directors' judgement, having regard to the most recent independent valuation report dated 29 July 2019 and an assessment of current pertinent real estate market conditions.
- (5) Tax Provision Item (c) includes where applicable, a provision for income tax on net unrealised gains on the Company's investments in securities and its share of Associated Entities' after-tax net profit for the month (deferred tax liability) and the recognition of future income tax benefits on net unrealised losses on the Company's investments in securities and its share of Associated Entities' after-tax net loss for the month (deferred tax asset).
