CHANGE OF DIRECTORS

The Company wishes to advise that following the Company's Annual General Meeting held on Friday 25 May 2007, Messrs Trevor Tennant and Seetoh Kwok Weng and Ms Heng Siow Kwee have retired from the Board. Messrs Tennant and Seetoh and Ms Heng have all been Directors of the Company since its listing on the ASX in 1998. The Board would like to extend its appreciation to these Directors for their valued contributions in various operational and financial aspects to the growth of the OMH Group. Ms Heng will remain as a joint company secretary to the Company as well as maintaining her current executive position.

Mr Ong Beng Chong has been appointed as a Non-Executive Director to the Board. Mr Ong is a Fellow, Certified Public Accountant, Singapore and has had extensive financial and corporate experience gained primarily in Singapore for various multinational companies, and is at present the Director of Finance and Corporate Services, South East Asia for one of the world's largest chemical manufacturing corporations.

As part of Mr Ong's remuneration he will be offered 500,000 unlisted options exercisable at 60 cents each on or before 31 May 2010. These options will be subject to shareholder approval at a General Meeting to be convened by the Company.

BACKGROUND PROFILE OF OM HOLDINGS LIMITED

OMH which was listed on the ASX in March 1998 has its foundations in metals trading – incorporating the sourcing and distribution of manganese ore products and subsequently in processing ores into ferro-manganese intermediate products. In the immediate future, the OMH Group now operates commercial mining operations – leading to a fully integrated operation covering Australia, China and Singapore.

Through its wholly owned subsidiary, OM (Manganese) Ltd (“OMM”), OMH controls 100% of the Bootu Creek Manganese Mine (“Bootu Creek”) located 110 km north of Tennant Creek in the Northern Territory.

Bootu Creek is designed to produce at an annual rate of 550,000 - 600,000 tonnes of manganese ore. Bootu Creek has further exploration potential given that its tenement holdings extend over 1,750 km².

Bootu Creek’s manganese product is exclusively marketed by the OMH Group’s own trading division with a proportion of the product consumed by the OMH Group’s wholly-owned Qinzhou smelter located in south west China.

Through its Singapore based commodity trading activities, OMH has established itself as a significant manganese supplier to the Chinese market. Product from Bootu Creek has strengthened OMH’s position in this market.

OMH also holds a 16% shareholding in Territory Iron Ltd, a company presently pursuing the development of the Frances Creek iron ore project in the Northern Territory.
