

NOTICE UNDER SECTION 708A(5) OF THE CORPORATIONS ACT 2001

This notice is given by Auroch Minerals Limited (**Auroch** or the **Company**) in relation to the issue of 18,227,344 fully paid ordinary shares (**Shares**) as detailed in the attached Appendix 2A and announced on 28 February 2020.
