DIRECTIONS

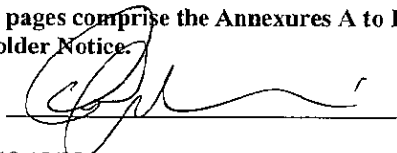
