Notice Given Under Section 708A(5)(e) of the Corporations Act

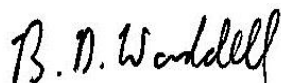
The Shares above are part of a class of securities quoted on ASX and may be subject to a subsequent offer for sale.
