<u>US COVID-19 Paycheck Program:</u> During the March 2021 quarter the Company's wholly owned US subsidiary Strata Energy Inc (Strata) received US\$0.560 million under the second round of the US COVID-19 Paycheck Protection Program. This is a US government sponsored program and consists of a forgivable loan to Strata specifically designed to help businesses keep their workers on the payroll during the COVID-19 pandemic. In accordance with this program Strata applied for and received approval for this loan and accrued interest to be 100% forgiven during the September 2021 quarter. This results in the Company having no outstanding loan under the US Paycheck Protection Program as at 30 September 2021. <u>Disclosure notes:</u> The financing facility disclosure above excludes miscellaneous and minor hire purchase agreements that meet the requirement under AASB 16 Leases to be classified as both a lease liability and a lease asset.
