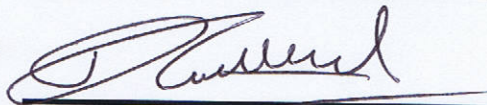

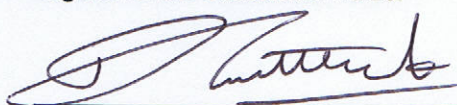
DIRECTIONS
