Non- Renounceable Rights Issue – Partial Allotment of Shortfall

Platina Resources Ltd (**Platina**) is pleased to announce the issue of a further 2,280,000 fully paid ordinary shares and 1,140,000 free attaching options (exercisable at \$0.35 each and expiring on 28 February 2011) have been allotted as part of the shortfall under Platina's non-renounceable rights issue, pursuant to Platina's prospectus dated 30 November 2009 (**Rights Issue**).
