Platina Resources Limited (Platina or the Company) wishes to confirm the allotment of 45,050,477 ordinary fully paid shares (Shares) at \$0.021 per share to raise \$946,060 to sophisticated, professional and other exempt investors, comprising existing and new shareholders (**Placement**) (before costs of raising) as announced on 16 June 2020.
